This contract represents continuation of our work in Bosnia and Hercegovina on strengthening anti-corruption capacities of BiH institutions.

ECG SUMMIT PROJECT UPDATE

Protection and promotion of property rights of internally displaced people, refugees and returnees upon readmission agreement

We are delighted to report on the ECG's successful implementation and competition of the EU funded project "Protection and Promotion of Property Rights of Internally Displaced People, Refugees and Returnees Upon Readmission Agreements", which was jointly financed by the EU and co-financed by the Office for Kosovo and Metohija.

During the last two years, the project was successful both, in terms of informing potential clients about the availability of our services and addressing many property & labor rights cases through four legal offices and two partner NGO legal aid offices in Kosovo. Some of these impressive statistics are reflected in the number of new cases opened (3,000) and number of court hearings attended on behalf of our clients (759).



Important accomplishments and highlights from the successful implementation of the project were presented at the Final Conference held on October 29th, 2018 at the Palace of Serbia In Belgrade

During the last two years, the project was successful both, in terms of informing potential clients about the availability of our services and addressing many property & labor rights cases through four legal offices and two partner NGO legal aid offices in Kosovo. Some of these impressive statistics are reflected in the number of new cases opened (3,000) and number of court hearings attended on behalf of our clients (759). Our team also played a crucial role in the privatization related cases. Once a week, our staff followed any new development on the website of the Kosovo* Privatization Agency (KPA) and quickly informed our clients to contact our offices and submit the necessary documentation

to prepare their claims. As a result, we have submitted more than 2,200 labor rights claims to KPA, and already more than 200 of our clients have received indemnization. This would not have been possible without the implementation of a well-designed and daily updated database that allowed us to follow-up on more than 7,600 cases.

Project performance in figures

- 7.592 cases uploaded of the previous and current projects on the database
- 158 refugee cases referred to HCIT of which 42 cases solved
- 3000 new cases opened
- 1860 cases closed
- 15 Training events for trainees and 3 visibility training events (18 events in total)
- 9 Thematic working groups events
- 2 surveys (initial and final) about the awareness of the targeted population
- 14 project visibility events
- TV commercial aired 767 times in 16 local TV stations
- RTS filming and broadcasting 7 episodes documentary on our project

Another important aspect of our activities were the visits to Kosovo*. These visits have been of significant importance for our project and our caseload. The legal environment (including new regulations) in Kosovo* may have had direct (negative) consequences/impact on our beneficiaries and their property rights.

Additionally, if we take a **more cost/benefit perspective**, it is important to note that the European Union invested 3.6 million euros in this project, but the following is what this project provided in return:

We provided services (revision of files and documentation, legal advice, preparation of submissions, legal representation in front of the courts, transportation costs, taxes, etc.) for a total value of Euros 990,000 that our beneficiaries would never have been able to afford, if they had to ask for the services of private lawyers. If the Legal Aid project didn't exist, we estimate that around 70% of our beneficiaries would not be able to submit their cases to the courts in Kosovo*. We recovered 28 properties for a value of 6.3 million euros and expect to recover very soon another 65 properties for an additional value of 6.6 million euros and some 220 families which presented a claim to KPA have already received a labor indemnization for a total amount of Euros 1,100,000.

ECG Summit was part of the Consortium led by Ecorys SEE, which was awarded the EU funded project in Serbia "Support to Public Administration Reform Visibility and Communication under the PAR Sector reform."

The project aims at providing a comprehensive assistance to the Government of the Republic of Serbia in pursuing visibility and communication related to PAR and PFM (Public Finance Management). The project includes three main components:

- 1. Awareness and visibility of the PAR and PFM process
- 2. Awareness of EU support to the PAR process and benefits for the citizens which the PAR process brings within the EU integration process
- 3. Communication capacities of MPALSG, MoF and public administration bodies.



The main role of PAR Communication and Visibility project, as a part of the Complementary Support to the Sector Budget Support Programme, is to look at the whole PA reform processes which started in 2004, to recognize priorities for communication in those processes, to make connections with other projects and strong relations with beneficiaries and stakeholders, as well as to prepare

and implement the comprehensive Strategic communication framework and plans for communicating the PAR and PFM to the public.

The project was presented to the representatives of the Contracting Authority, EUD to Serbia, the main beneficiary Ministry for Public Administration and Local Self-government (MPALSG), other beneficiaries Ministry of Finance (MoF) and Public Policy Secretariat (PPS) at the kick-off meeting held on 1st of August 2018.

ECG Summit Director and Founder Danijel Pantic became a member of the Working Group within the Ministry of Environmental Protection of the Republic of Serbia for implementation of the Paris Declaration and the PEP/Transport Health and Environment Pan European Programme. The proposed objectives of this Working Group include:

- Drafting of the National Action Plan for transport, health and environment, as well as a National Strategy for byciclism with the aid of UNECE and the World Health Organization;
- Implementation of objectives/goals of the Paris Declaration /PEP Transport Health and Environment Pan European Programme;
- Cooperation with various sectors as they relate to environmental protection and to the PEP Transport Health and Environment Pan European Programme;
- Further analysis, discussions and recommendations for implementations of activities on the national level as they relate to promotion of concepts of sustainable healthy mobility and other activities as they relate to environmental protection and health, with goal of preventing climate change;

One area of focus for this Working Group is support for development of bicycle infrastructure projects, such as three EuroVelo Routes 6,11 and 13 in Serbia.
